ACCESS CONTROL

TO STOP ANY VEHICLES ENTER/EXIT THE CAMPUS

INSPECTION OF VEHICLES THAT ENTER / EXIT INTO THE CAMPUS.

CHECKING VEHICLE STICKER / VISITOR PASS / CAMPUS CARD / WORKING PASS

TO DETAIN ANY TRANSPORT/ INDIVIDUAL SUSPECTED IN CRIME



TRAFFIC CONTROL

ROAD TRAFFIC CONTROL IN THE CAMPUS DURING PEAK TIMES.

ISSUING TRAFFIC SUMMONS TO INDIVIDUALS WHO BREAK TRAFFIC RULES.

LOCKING (CLAMP) VEHICLES VIOLATING TRAFFIC RULES.



PATROL CAR

- CARRYING OUT SECURITY PATROLS WITHIN THE CAMPUS AREA.
- CHECKING SUSPICIOUS INDIVIDUALS.
- ESCORT VIP'S VEHICLES FOR ACTIVITIES/PROGRAMS ORGANIZED BY THE UNIVERSITY.



CRIME INVESTIGATION

- CONDUCTING INVESTIGATIONS INTO CRIMINAL CASES REPORTED TO HAVE OCCURRED ON THE CAMPUS.
- CARRY OUT MONITORING & SURVEILLANCE TASKS TO PREVENT CRIMINAL ACTIVITIES IN






CONTROL ROOM


- SECURITY COMMUNICATION CENTER ON THE CAMPUS.






ARREST OF A MOTORCYCLE THEFT SUSPECT

- TAKE CARE OF PERSONAL PROPERTY AS BEST.
- USING THE CAMPUS BUS PROVIDED TO LECTURE HALLS, LIBRARY ETC.
- ALWAYS BE WITH A FRIEND WHEN WALKING AT NIGHT.

DON'T

- BE OUTSIDE THE COLLEGE PREMISES AFTER 12.00 MIDNIGHT.
- POSSESSION, OWNING AND RIDING / DRIVING A VEHICLES WITHOUT PERMISSION IN CAMPUS.
- ENGAGE IN ANY GAMBLING ACTIVITIES.
- BRINGING IN ALCOHOLIC, DRUGS AND OBSCENE SUBSTANCES.
- ENGAGE IN OFF-CAMPUS WORK WITHOUT PERMISSION.
- TRESPASSING IN PROHIBITED AREAS ON THE CAMPUS.
- ORGANIZING PROGRAMS / ACTIVITIES ON CAMPUS WITHOUT PERMISSION.
- PUBLISH AND DISTRIBUTE ANY LEAFLET OR WRITTEN DOCUMENT WITHOUT AUTHORIZATION.
- BRINGING INSIDE PERSONS OR OTHER STUDENTS INTO THE COLLEGE PREMISES WITHOUT AUTHORIZATION.
- MOVING PLACE OF RESIDENCE WITHOUT THE PERMISSION OF THE COLLEGE.
- MAKING NOISE TO THE EXTENT OF DISTURBING OTHER STUDENTS.
- ENTER AND LEAVE THE CAMPUS AFTER MIDNIGHT WITHOUT PERMISSION.
