ESTIMATION OF LIVING COST

The cost of living for international students studying at UPM is reasonably low compared to international standards and can vary from USD 300 to USD 400 a month (not inclusive of accommodation) depending on individual needs and lifestyle. All the necessary facilities and amenities are readily available within the campus and its vicinity for the convenience of the students. The student should have adequate money to cover living expenses, clothing, books, travel, etc.

(i) On-campus

International students are advised to reserve their accommodation before coming to Malaysia as apartments and rooms in residential colleges are extremely limited. The cost of on-campus accommodation can vary from USD100 – USD500 per month.

(ii) Off-campus

Off-campus accommodation around the UPM campus is within a radius of 1–10 km. There are various types of accommodation, which include flats, apartments, condominiums, and terrace houses. The cost can vary from USD150 – USD650 per month / RM 500 – RM 2,000.

- a) The Academia, South City Plaza Apartment (5 km from campus)
- b) The Heritage Residence (3.9 km from campus)
- c) Mutiara Residency (5 km from campus)
- d) UNIV 360 Students (4.6 km from campus)

Student transportation inside and outside of the campus is available via UPM Bus Service. Students are expected to pay approximately RM75.00 per semester for unlimited rides.
